7. Applications to vote by proxy at this election must reach the Electoral Registration Officer by 5pm on Tuesday 27 April 2021.
8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity, or for work/service reasons must reach the Electoral Registration Officer by 5pm on Thursday 6 May 2021. The physical incapacity must have occurred after 5pm on Tuesday 27 April 2021. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday 27 April 2021.
